

# Residential Electricity Rates Effective July 1, 2012

These electricity rates apply to energy used on or after July 1st 2012. All rates are approved by the Ontario Energy Board.

Time of Use

### **Electricity Charge**

The cost of electricity supplied to you during this billing period. Summer Time of Use rates took effect May 1, 2012 and did not change July 1. The Ontario Energy Board will set new rates again on November 1, 2012. Please see our website for more information on Time of Use pricing.

#### **Delivery Charges**

The cost to deliver the electricity from generating stations across provincial transmission lines and through Halton Hills Hydro's distribution system to your home. Rates are set by Halton Hills Hydro and Hydro One. Residential distribution charges reflect a modest decrease over previous rates.

## Ontario Clean Energy Benefit (OCEB)

A 10% rebate applies to all of the above charges and also the HST. This rebate is in effect until the end of 2015 to help customers transition to a cleaner, modern electricity system. All residential and general service under 50 kW customers are eligible to receive the OCEB.
