

## Electricity Pricing Choice

If you're a residential or small business customer, you can choose to switch between Time-of-Use (TOU), Ultra-Low Overnight (ULO) and Tiered prices.

These prices affect the 'Electricity Charges' section of your bill.

## Time-of-Use (TOU) Pricing

TOU pricing depends on when you use the electricity. You can help manage your electricity costs by shifting your usage to lower price periods when possible.

## Tiered Pricing

Tiered Pricing allows you to use a certain amount of electricity at a lower price. Once you exceed that limit; a higher price applies.

## Ultra-Low Overnight (ULO) Pricing

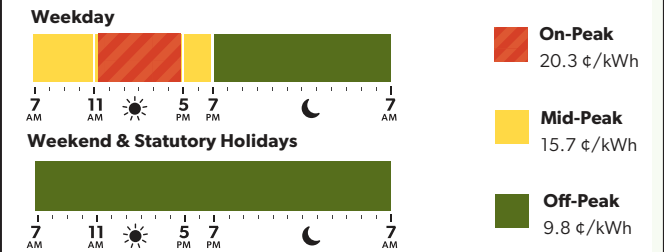
The ULO pricing plan is similar to the TOU pricing plan as it applies different rates to your consumption based on when you use electricity. As the name implies, the ultra-low overnight rate encourages shifting high electricity-usage activities to lower-demand periods overnight.

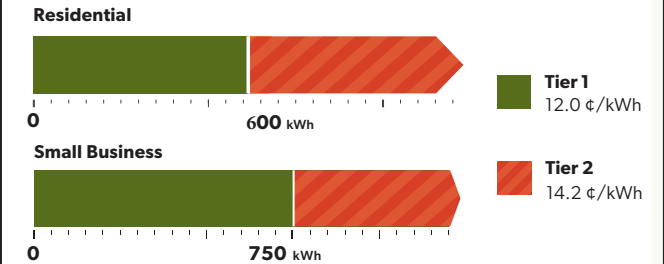

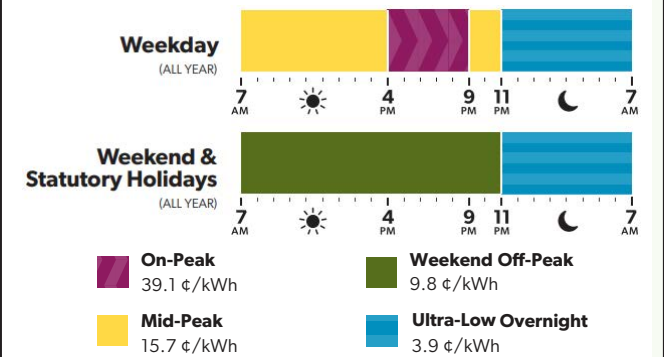
## Summer Time-of-Use (TOU) prices per kWh

## Ontario Electricity Rebate (OER)

Effective November 1st, 2025, the OER is 23.5%.

All residential and small commercial customers are automatically eligible for the rebate. You do not need to apply. Certain categories of customers including retirement homes, mobile home parks and common areas in residential multi-unit complexes such as condominium buildings need to submit a self-declaration form to receive the rebate.
